ICA-FOLD lays flat on the wall providing an exceptionally smooth surface for re-siding. By overlapping or butting the sections, escaping air is virtually eliminated. ICA-FOLD is perforated to reduce condensation buildup, and enhances the performance of your home's existing insulation. Economical and efficient when installed properly, it will help to conserve energy by allowing your heating and cooling systems to operate more effectively.
