### ► *Easy to Install*

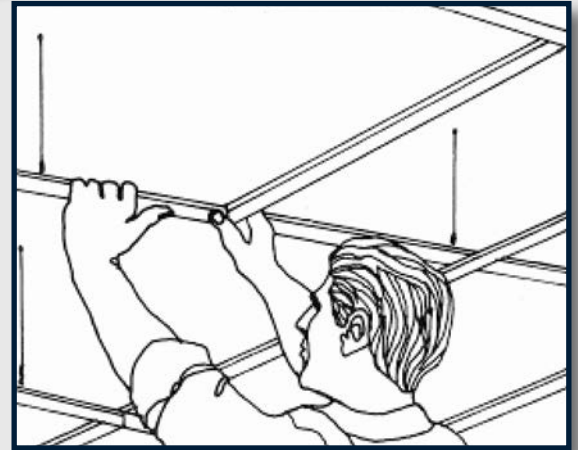
- Simply lay in grid system. Use a sharp knife to trim panels where needed.

Though ICA-TILE is manufactured from modified beads, it should be considered combustible.
